Terms and Conditions

These Terms and Conditions outline the policies of Endless Fun Events. By booking our services, you agree to the following:

1. Reservation and Deposit

- A non-refundable **\$100 deposit** is required to secure your event date.
 - Your date is not confirmed until the deposit is paid.
 - Remaining balance is due **14 days before** your event.

2. Payment

- Payments may be made through any approved method listed on your invoice.
 - If the final balance is not received by the due date, Endless Fun Events reserves the right to cancel the booking without refund of the deposit.

3. Travel

- Complimentary travel is included within **30 miles of Newnan, Georgia**.
 - Events beyond this radius may incur a travel or fuel fee.
 - Parking and venue-related fees, if required, are the client's responsibility.

4. Setup Requirements

- Client must provide a safe, level space for setup.
 - Access to one **standard power outlet** is required for the booth.
 - For outdoor events, appropriate shelter or covering must be provided.
 - We require at least **45 minutes** to set up before the event start time.

5. Service Time

- Service time includes active operating hours of the booth.
 - **Idle time** may be added at an additional cost if you want the booth paused during speeches, meals, or program transitions.
 - Each package includes unlimited sessions during active operating time.

6. Equipment and Safety

- Endless Fun Events is not responsible for accidents or injuries caused by unsafe guest behavior.
 - Any damage to equipment caused by guests or venue conditions may result in a repair or replacement fee.

7. Photo Template Approval

- All custom templates must be approved by the client at least **14 days before** the event.
 - If approval is not received in time, a default design will be used.

8. Attendant

- An on-site host is included with most booth options to ensure smooth operation and proper use of equipment.
 - The host reserves the right to stop service if guests behave in a way that threatens equipment or safety.

9. Weather Policy

- Outdoor events must provide full protection from rain, wind, and direct sunlight.
 - If weather conditions are unsafe, the booth must be moved indoors.
 - If no suitable indoor space is available, we may be unable to operate, with no refund issued.

10. Photo Usage

- Endless Fun Events may use photos and videos captured during your event for marketing purposes unless you request otherwise in writing prior to your event.

11. Cancellation and Rescheduling

- Deposit is non-refundable.
 - If you cancel less than **14 days** before the event, the full balance is due.
 - Rescheduling is allowed at no additional fee if the new date is available.
 - If the new date is unavailable, the booking will be treated as a cancellation.

12. Liability

- Endless Fun Events is not responsible for events outside of our control including power outages, venue restrictions, weather, or guest interference.
 - In the rare event that we cannot provide service due to equipment failure or emergency, you will receive a full refund of all payments made.

13. Client Responsibilities

- Provide accurate event details.
- Ensure venue approval for the photo booth.
- Provide necessary access and setup instructions.
